Frigidaire Laundry Recall

The Electrolux Group, in cooperation with the U.S. Consumer Product Safety Commission (CPSC), has announced a voluntary recall of certain Frigidaire gas laundry centers due to a safety issue with the felt seal on the dryer drum, which can be folded inward and can lead to an accumulation of lint, creating a fire hazard.
