**MINIMUM ADVERTISED PRICING (MAP) POLICY FOR DANBY AND SILHOUETTE
BRANDED APPLIANCES**

GENERAL GUIDELINES

Danby Products Inc. has developed a minimum advertised price (MAP) policy on our appliances that applies to both retail and Internet advertised pricing. Our MAP policy has been developed to ensure that our dealer partners achieve maximum value for their products and features. Minimum advertised prices have been developed based on market conditions and product value and will be updated periodically to reflect changes in these conditions.

A MAP schedule accompanies this document that outlines the models that are impacted, and the associated minimum advertised price required. The schedule is subject to be changed or be updated as required by Danby Products, Inc. at any time with 30 days' notice. All Danby dealers are required to strictly adhere to the MAP policy as provided, and violation will occur anytime that an advertised price is below the price identified on the MAP schedule.

The policy applies to all advertisements of applicable Danby and Silhouette appliances by dealers in any and all media, including, without limitation, newspapers, magazines, catalogs, other print media, television, e-mail, internet websites, brochures, any method which uses a web based shopping cart, and other electronic media.

The MAP Policy defines the lowest price authorized to be advertised in order to maintain the product equity. This policy applies to all dealers within the United States. Advertisements that do not comply with Danby's MAP program guidelines will be considered a violation and, without assuming any liability, Danby may issue written notification of failure to follow the Policy and be forced to execute the consequences listed below.

All advertisements that include prices must meet the following requirements in order to be deemed in compliance with Danby's MAP Policy:

1. Dealers cannot advertise any price in violation of said MAP Policy either online or print at any publication including those of any third-party. Third-party includes retailers, price comparison websites, search engines, auction websites, distributors, or any company conducting commerce.
2. A "click for price" button, or any other method on a website intended to solicit potential customers to put the product in a cart that displays a price lower than the MAP guidelines is a violation of the MAP Policy.
3. Free shipping and/or free financing promotions do not violate this MAP Policy as long as the advertised price is not below the MAP price.
4. The MAP Policy shall not apply to the final "Checkout" stage for online purchases. This area of a dealers website are those web pages where:
 - Consumer has acted in a deliberate manner to "go to Checkout" or "make purchase payment", by clicking on buttons designed for such purpose.
 - Consumer's personal information is required, most commonly name, address, or login information that is inclusive of this personal information.

Danby will be enforcing a “zero” tolerance policy to uphold the retail pricing and the integrity of the product line. If any dealer is found to be in violation of the MAP policy, the following will occur:

- **1st Offense** - Where a violation occurs on a specific model(s), Danby will suspend shipments of all MAP products for minimum period of (60) days, effective immediately from the date the violation has occurred.
 - **2nd Offense** - Where a 2nd violation occurs on a specific model(s), Danby will suspend shipments of all MAP products for a minimum period of (six) months, effective immediately from the date the violation has occurred.
 - **3rd Offense** - Where a 3rd violation occurs on a specific model(s), Danby will suspend shipments of all MAP products for a minimum period of (twelve) months, effective immediately from the date the violation has occurred. In addition, Danby will suspend any merchandising support during the fiscal period in which the violation occurred. Merchandising support can be identified as any or all of the following:
 1. Volume rebates paid directly to the dealer from Danby. Volume rebates paid to national or regional buying groups will be calculated based on removal of volume from any dealer within that buying group who were found to be in violation of MAP policy.
 2. Suspension of merchandising accrual and support, other than volume rebates, which have been negotiated between Danby and the dealer or the associated buying group.
- Danby will not reimburse for any portion of the advertisement in question.
 - Before any additional reimbursement is given, Danby will require visual proof of all advertisement where Danby support is requested, for a period of (twelve) months after the date that any violation has been identified.
 - Danby will suspend any merchandising support to a Distributor, Retailer, Regional warehouse or other Distribution network who sells or distributes to a dealer when the dealer breaks the MAP policy.
 - Exceptions to stated MAP policy would occur only upon approval by associated Danby Products, Inc. personnel or representatives.
 - Rebates offered by anyone other than the manufacturer (Danby) cannot be used to reduce the posted MAP price on an applicable sku unless agreed upon by Danby.
 - When supplementary promotional items are offered, the value of those items (including free delivery, 10% off sales, free premiums, free financing, gift cards, or other similar offers) may not be stated or implied in the advertisement or netted from the advertised price if the result would be a net price lower than the stated MAP.
 - Supplementary promotional items listed above can be advertised only if the resulting net retail price does not break MAP price on the applicable sku.
 - **All notices of MAP violations will be in writing only to the dealer and will include a copy of the current Danby MAP Policy, as well as documentation (visual aid) of the offense.**

ADVERTISING GUIDELINES

Dealer advertisements must follow the following guidelines and are subject to approval by Danby Products Inc. Failure to follow these guidelines may result in termination of the dealer's ability to purchase Danby and Silhouette products.

1. All advertisement(s) must include Danby model numbers that are complete or sufficient in Danby's sole and absolute discretion to specifically identify the advertised product(s).
2. Advertisement(s) must display appropriate brand name prominently containing the correct and authorized logo, product imaging, and model number. Display advertisements deliberately depositing or illustrating Danby and Silhouette branded products without brand names fail to meet merchandising principals that emphasize the value and quality of Danby and Silhouette branded products. All advertisements must contain the correct product image corresponding to the model number.

Danby Products Inc. has adopted this Policy to coincide with its independent business strategy and reserves the right to change this MAP Policy and to enforce and otherwise handle all questions and issues related to this MAP Policy. Interpretation and application of this Policy shall be made exclusively by Danby in its sole discretion.
